Procurement Event under the Utility-Scale Wind RFP

Invitation to Comment on the Contract Form

Public Act 99-0906 (the “Future Energy Jobs Act”) was signed into law on December 7, 2016 and became effective June 1, 2017. Pursuant to this legislation, the Illinois Power Agency (“IPA”) filed its long-term renewable resources procurement plan (“LTRRPP”) on December 4, 2017, which was approved by the Illinois Commerce Commission (“ICC”) with modifications on April 3, 2018. The approved LTRRP provides for the procurement of RECs from new utility-scale wind projects through 15-year fixed-price contracts.

The Utility-Scale Wind RFP seeks to procure at least 1 million RECs delivered annually from new utility-scale wind projects.

NERA Economic Consulting has been retained by the IPA as the Procurement Administrator for the procurement event. This invitation is to invite interested parties to comment on the standard contract form to be used under the Utility-Scale Wind RFP.

On August 19, 2019, the Procurement Administrator posted to the [procurement website](#) a draft of the Wind REC Contract (the “DRAFT Wind REC Contract”). The DRAFT Wind REC Contract is proposed to be the standard contract form for the Utility-Scale Wind RFP between each winning supplier and Ameren Illinois Company (“AIC”) and/or Commonwealth Edison Company (“ComEd”). The Procurement Administrator has also posted a redline document showing the changes between the FINAL Wind REC Contract from the Fall 2018 Utility-Scale Wind RFP and this DRAFT Wind REC Contract. Except as otherwise expressly set forth in this Wind REC Contract, this Wind REC Contract is governed by all the terms and conditions of the form of the agreement entitled “Master Renewable Energy Certificate Purchase and Sale Agreement,” which is attached thereto.

The Procurement Administrator invites interested parties to submit their comments on the DRAFT Wind REC Contract. All comments received in accordance with the process outlined below will be reviewed by representatives from the IPA, Ameren Illinois Company, Commonwealth Edison Company, the Procurement Administrator, the Procurement Monitor, and Staff of the Illinois Commerce Commission. The timeline and process for interested parties to provide comments is as follows:
