Product Information:

- A REC is a Standard REC and represents all the environmental attributes corresponding to one megawatt-hour of energy generated from renewable energy sources.
- The Target for the procurement event is given below:

Description	Target
RECs associated with utility-scale wind projects	1,000,000

- If the Project is operational, the Date of First Operation of the Project cannot have occurred on or before June 1, 2017. If the Project is not yet operational, the expected Date of First Operation must be on or before October 30, 2022.
- A Project cannot be located outside of the state of Illinois and the states adjacent to Illinois. States adjacent to Illinois are Wisconsin, Iowa, Missouri, Kentucky, Indiana, and Michigan.

A Bidder may present Bids for multiple projects as long as the sum of the minimum quantities does not exceed the Target.

Complete and Sign Certification:

I, John Smith, certify under penalty of perjury that I am authorized to submit these Bids.

By affixing my electronic signature below I understand and agree to the following: Any Bid submitted for this procurement event will remain binding until seventeen (17) business days after the Bid Date. The price in the Bid constitutes a binding and irrevocable offer to supply the annual quantity of RECs from the Project selected in the evaluation at the price in the Bid and under the terms of the REC Contract. The annual quantity selected in the evaluation is an annual quantity in the REC Contract aggregated across all Companies that is not less than the minimum quantity provided in the Bid and that does not exceed the full quantity provided in the Bid. If the ICC approves some or all of the Seller's Bids, the Seller will execute the REC Contracts with the Companies as instructed by the Procurement Administrator and the Seller will submit all necessary supporting documentation in the timeframe required by the REC Contract.

Notes:

- A Bid for a Project has three elements: (i) a price per REC; (ii) a full quantity, which is an annual quantity of RECs that the Seller is offering to deliver under the terms of the REC Contract; and (iii) a minimum quantity, which is a minimum annual quantity of RECs that the Seller is willing to accept as a partial award.
- The full quantity and the minimum quantity must each specify an integer number of RECs.
- The full quantity must not exceed the Target. The full quantity must not exceed the Maximum Bid Size.
- The minimum quantity must not exceed the full quantity.
- The price in the Bid must be a \$/REC and must display as a number rounded to the nearest cent.
- Only one Bid may be submitted for a Project.
- The sum of the minimum quantities across all Projects presented by a Bidder must not exceed the Target.
- The quantity of RECs bid for a Project cannot exceed the "Maximum Bid Size", which is the product of: (a) the Project size in MW (AC rating), (b) a capacity factor of 45%, and (c) 8760 hours.
